Minutes of the 102nd Annual Business Meeting of the American Society for Clinical Pathology Friday, September 5th, 2024 · Annual Business Meeting

Robert A. Goulart, MD, MASCP, ASCP President, called the 102nd Annual Business Meeting of the American Society for Clinical Pathology to order and thanked the members for attending.

Report of the Treasurer – Diana L. Kremitske MHA, MS, MLS(ASCP)

Ms. Kremitske presented the Treasurer's Report and gave an overview of ASCP's revenue and expenses for FY2024. She reported that ASCP ended FY2024 with positive income from operations. The financial result was consistent with the prior year's performance.

ASCP finances were audited by the firm of Plante and Moran. In their opinion, the financial statements fairly represented the financial position of ASCP as of June 30, 2024. The firm felt that the management records were organized and fully available to the auditors.

Report of the Secretary – Walter Oliveira, MASCP, MLS(ASCP)^{CM}, SI

The minutes from the October 20th, 2023, ASCP Annual Business Meeting were posted on the ASCP Website and were available prior to this meeting. A motion was made, seconded, and carried out:

Approval of the minutes from the 101st Annual Business Meeting held on October 20th, 2023, in Long Beach, CA.

Mr. Oliveira reported that membership continues to be stable. As of September 5th, there were 10,843 physicians and 60,604 laboratory professional dues-paying members. Additionally, ASCP has 3,317 members in residency or fellowship programs, along with 3,980 laboratory science student and 787 medical student members. ASCP has approximately 100,000 members.

Mr. Oliveira concluded his report and asked for a moment of silence for members who had passed away in the past year.

Report of the Bylaws Committee – Cheryl Germain, MHS, MASCP, PA(ASCP)^{CM}

As Chair of the Bylaws Committee, Ms. Germain provided a report regarding the proposed amendments within the ASCP Bylaws, specifically concerning the Nominations Committee selection process and changing the word "credentialing" to "certification" in the Board of Certification section of the Bylaws. The Board of Directors approved the proposed amendments, which were then voted on by eligible ASCP members and adopted as of September 5th, 2024.

Report of the ASCP Foundation Board of Trustees - Anne Walsh-Feeks, MS, MASCP, PA(ASCP)CM, FACHE

As President of the ASCP Foundation Board of Trustees, Ms. Walsh-Feeks provided a report concerning its operations to date and a financial overview of fund balances (General, Global Health, Scholarships, Lab Visibility, Cindy Johns, Partners in Cancer Diagnosis). The total Fund Balance of the Foundation is \$1,229,182.
